INVITATION FOR BIDS - MISCELLANEOUS I&C PACKAGE

Coastal Energen Pvt Ltd (ENERGEN), is setting up 2x600MW coal based Thermal Power Project in the Tuticorin District, in the state of Tamil Nadu in India.

ENERGEN has already awarded Contracts for supply of BTG, Civil & structural works of main plant, Coal Handling plant, Ash handling plant, Electrical Balance of Plant & GIS, Water system, BTG Erection and IDCT among other packages. Now Energen invites offers from competent EPC contractor for 'Miscellaneous I&C package' for 2 x 600 MW Power Plant on turnkey basis.

Brief scope of work

The scope comprises of Design, Engineering, Material selection, Manufacturing, Testing at works, Supply to site, Construction, Installation, Commissioning, Performance testing at site, and other related work for Miscellaneous I&C Package. The package includes all other related equipment including spares and consumables for the following systems:

- AAQMS (Ambient Air Quality Monitoring System) instruments
- The analyser system for mercury monitoring in stack
- Plant security and surveillance system (PSS) including CCTV, Access control system, Perimeter detection system, Patrolling system & Attendance monitoring system.
- Management Information System (MIS).
- Computerised Maintenance Management System (CMMS)
- Station LAN

Minimum Pre-qualifying requirements:

The intending bidder shall meet the following pre-qualifying requirements and furnish documentary evidence in support of the same.

- (i) **Technical requirement:** Bidder should have designed, Manufactured, Supplied, Erected, commissioned, tested and integrated at least Three or more packages of those listed above for a coal based thermal power plant of minimum 210MW capacity which is under construction or in successful operation for at least one year as on date of opening of bid.

The original equipment manufacture of each of the sub systems should have designed, manufactured, supplied, tested and commissioned accessories for 210MW and above capacity.

BIDDER should have adequate capability to integrate and coordinate civil, electrical and I&C works of various packages on his own or in association with reputed consultants.

- (ii) **Financial requirements:**

The Bidder shall be financially sound and shall have adequate financial resources to execute the contract concurrently with his other commitments and shall meet the following conditions:

- a) The Bidder shall have a positive net worth as per latest audited financial statements.



- b) The Bidder shall have an average annual turnover of not less than Rs.25 (Twenty five) crores during the last 3 years ending with 31-03-2010 and have executed similar job costing not less than Rs. 5 (Five) crores in previous three years in a single contract.
- c) The Bidder shall furnish his audited profit & loss account and balance sheet for the last 3 years.
- d) Contracts on hand /pending jobs and their status along with value also should be furnished by the bidders

Issue of Bid documents

Interested Bidders or their authorized representatives who meet the above qualifying requirements may collect the Bid documents from the following address in person/ by post/ by courier on submission of a written request along with supporting documents to demonstrate meeting the above qualifying requirements and a non-refundable payment of Rs 5000 (Rupees Five thousands Only) towards the cost of Bid Documents in the form of a crossed demand draft drawn in favour of Coastal Energen Pvt Ltd payable at Chennai.

Earnest Money Deposit

The bidder shall submit a Demand draft or a Bank Guarantee from a nationalised/scheduled bank for an amount of Rs 2.0 (Two) Lakhs towards EMD. The Bank Guarantee shall be valid for a period of six months from Bid date. The Earnest Money Deposit paid in the form of Demand Draft will be refunded by means of Account Payee Cheque to the unsuccessful Bidder as soon as the tender is finalised. This amount shall not carry any interest. In case of successful Bidder, the EMD shall be returned after the Security Deposit/Contract Performance Guarantee is furnished on award of contract. The EMD will be forfeited if the Bidder (i) withdraws his tender after acceptance or (ii) withdraws his tender before the validity date.
