The coal is intended for supplying power against short term tender by Tangedco which has a penalty of Rs 2.5 crore per day if we default in supply of power.

- 2. **Vessel**: Vessel with draft restriction of 14 metres. **In case of gearless vessel, additional cost** incurred for discharge is to be borne by the Supplier.

In case of any delay in arrival, LD @ 0.1% of coal value per day will be levied on the supplier and the loss due to risk purchase will also be payable by the supplier after a grace period of 5 days.

6. Payment:

40% of payment will be released on discharge of vessel at TTN port after necessary documents are provided by the seller for vessel berthing, custom clearance and proof of non-encumbrance from any agency on the subject coal. Dispatch of 100% quantity to be commenced immediately upon receipt of 40% payment.

Balance 60% payment will be made within 45 days from the completion of despatch to plant.

In case of any LD deductions as mentioned above, the payment will be made after deducting the same and the DO is to be released after accepting and adjusting the deductions.

The coal from our concluded vessel / quantity cannot be sold to any third party for a period of at least 90 days without our prior written consent of the Buyer.

7. **Delivery**: 100% DO shall be released and dispatch should start immediately upon receipt of 40% payment.

8. **Despatch Rate**: Seller should maintain the Min despatch rate of 300 trucks per day to the plant or else suitable LD will be levied.

9. Specification:

Our preferred coal will be from Kideco / Adaro / BMB/KG/BBA/Insani/Indexim/RUB mines. However, we may consider other origin / off spec high ash cargos along with low GAR Indo coals. Our typical requirement is for 4200 GAR with max 20% Ash, 0.4% Sulphur and can be achieved by blending multiple coals.
